

Of the capital stock of Dürr Aktiengesellschaft in the amount of € 177,157,324.80 – divided into 69,202,080 no-par value bearer shares – 31,331,640 shares were represented at the annual general meeting with an equal number of votes. This is equivalent to 45.28% of the company's registered capital stock. In addition, we received postal votes for 20,285,133 shares with an equal number of votes. Together this is equivalent to 74.59% of the company's registered capital stock. Votes were cast on the resolutions proposed by the Board of Management and the Supervisory Board and/or by the Supervisory Board as announced in the German Federal Gazette on March 24, 2021.
